SI. No.	GENERAL CONDITIONS
1.	The total number of section of the school shall be restricted to 22 (As per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subjected to specific approval of the Board on the basis of the request of the school as per affiliation bye laws.
2.	Compliance of the points no. 1 to 6 may be submitted within 03 months on the SARAS Portal, failing which due action will be taken.

SI. No.	CONDITIONS FOR COMPLIANCE

1	The number of sections shall be strictly restricted to 22 only and school shall not increase the sections without approval by the Board as per the affiliation bye laws. The strength each section shall be restricted to 32 students only as per the dimension of the classrooms
2	The school is directed to upload the latest safe drinking water and sanitation certificate on saras portal within 03 months as per appendix XIII of circular no 12/2022.
3	The school is directed to upload the recognition certificate issued by the state govt on saras portal within 03 months.
4	The school shall ensure the safety of students in school campus and shall make strict compliance of ule 4.7.6 of the affiliation bye laws.
5	The school is directed to ensure the infrastructure and facilities for the CwSN as per RPwD, Act 2016 and the affiliation bye laws. School have ramp/lift to access the upper floors and CwSN toilets with recommended infrastructure at each floor as per circular no 05/2023 dated 05.03.2023 and to upload the compliance on SARAS portal within 03 months with videography covering the CwSN facilities.
6	The school shall ensure the training of its teachers from the CoE pune and shall upload the compliance on saras portal within 03 months.

The above is subject to fulfillment of the following conditions:-

- 1. The decision of the Board for grant is based on declaration/data/information in self certification/DEO certification/application/OASIS data school as submitted by school and report of Inspection Committee. The genuineness of information / documents / data submitted in that declaration/data/information in self certification/DEO certification/application/OASIS data shall be of school and in case, if found otherwise the school shall invite action as per Affiliation Bye-Laws-2018.
- 2. The school is required to posses valid No Objection Certificate (NOC) and Recognition Certificate for running the school issued by the appropriate authority.
- 3. The school should go through the provisions of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and retain a copy for reference purpose and is also advised to visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ regularly for updates.
- 4. The School management shall ensure that only CBSE School will be run in the School premises demarcated for the CBSE School and no other institution is permitted in the School premises.
- 5. The School is required to apply online for further extension of Affiliation as per norms of the Board.
- 6. Further, the School is directed not to submit any forged/ fake documents to the Board.
- 7. The Board reserves the right to conduct inspection of school as per clause 11.2 and 11.4 of Affiliation Bye Laws.
- 8. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".
